SEFAA's mission is to (1) provide seminars, classes, workshops, and other educational events on fiber art topics, (2) to sponsor fiber art exhibitions, (3) to provide facilities for the promotion and appreciation of the fiber arts, (4) to sponsor special events open to the public focused on the fiber arts, (5) to promote innovation and excellence in the fiber arts, (6) to preserve fiber art skills and traditions, (7) to educate the public about fiber arts, and (8) to be a regional fiber arts resource.

SEFAA moved into rental space on Sept. 1, 2011 which includes two artists' studios as well as a large communal space for meetings, educational programs, fiber-arts-related events and exhibitions. Both artists' studios are currently leased to one artist, a crocheter who is launching his own small business, and the communal area was used for two Atlanta Knitting Guild events in 2011. Opening the SEFAA Center furthers SEFAA's mission to provide facilities for the promotion and appreciation of the fiber arts, to provide educational programming on fiber art topics, to sponsor fiber art exhibitions and events and to be a regional fiber arts resource.

4b (Code:) (Expenses \$ 1,048 including grants of \$ 0) (Revenue \$ 1,081)

SEFAA sponsored several events in 2011 - a booth at STITCHES South in March, a Fiber Garage Sale in May, a yarn bombing in June, and an Artists' Sale in November. The largest of these events was the Artists' Sale which was held to showcase fiber art produced by SEFAA member artists, to promote member fiber artists and their work, and to provide a one-time retail outlet for their fiber art. The Fiber Garage Sale was a low-cost way to buy and sell new and used fiber art materials, equipment, and supplies. Items left over at the end of this popular event were donated to Creative Reuse, another 501(c)(3) nonprofit. The yarn bombing in Freedom Park drew both planned and unplanned participants and, since the work stayed up in Freedom Park for a month, impacted the public well beyond the actual day of the event. SEFAA's booth at STITCHES South introduced knitters and crocheters to the wide variety of other fiber art techniques and to the regional resource that SEFAA comprises. These events all served to educate the general public about the fiber arts as well as the breadth of techniques and diversity that the term fiber arts encompasses. In addition, the sale introduced the public to the newly opened SEFAA Center and to the fiber art resource in the midst of their community.

SEFAA offered six seminars and classes in 2011, four of which were offered (the other two did not have minimum enrollment and were cancelled.) The four include Ethnic Textiles in January, Beading+Knitting+Wow! in June, From Dance Costume to Fine Art: A Biography of Bogolon Cloth in July, and Breaking through Creative Blocks in October. All of these educational offerings were well attended and further SEFAA's mission to provide seminars, classes, workshops and other educational events on fiber art topics.

Form 990, Part III, Line 2 - SEFAA leased space and opened the SEFAA Center in 2011 allowing the organization to provide low-cost rental space. Two artists' studios are currently leased and the large communal area of the SEFAA Center is available for rent for fiber-art-related activities. This supports SEFAA's mission to provide facilities for the promotion and appreciation of the fiber arts.

Form 990, Part VI, Section A, Line 4 - On December 16, 2011, the Board of Directors of the Southeast Fiber Arts Alliance adopted Restated Articles of Incorporation. The restated articles were filed by the Georgia Secretary of State on 1/26/2012 (Control No. 09056370) The major changes included: changing the mailing address of the registered office and adding exculpatory language to limit the liability of corporation directors. Also, on December 16, 2011, the Board of Directors of the Southeast Fiber Arts Alliance adopted amended and restated bylaws. Major changes included: strengthening the indemnification language, adding a Whistleblower Protection Policy, and eliminating all references to business members.

Form 990, Part VI, Section A, Line 6 - SEFAA had 68 individual and 6 organizational members at the end of 2011. Memberships are good for a full calendar year from the date of payment and so are rolling, rather than calendar year memberships. Membership charges are \$50 for individuals and \$100 to \$300 for organizations depending on their size. Members elect SEFAA's Board of Directors, but do not approve Board decisions or share in any of the corporation's profits.

Form 990, Part VI, Section A, Line 7a - Per Paragraph 7.2.2 of the SEFAA Bylaws, Directors are elected at the Annual Meeting of members held in February of each year. Each year half of the director's positions are up for election.

Form 990, Part VI, Section B, Line 11b - A copy of this completed Form 990 including all schedules was emailed to all members of the Board of Directors on May 6, 2011. The Board of Directors unanimously voted by email to approve the return for submission to the IRS with minor changes which were incorporated.

Form 990, Part VI, Section B, Line 12c - Article 11.6 of the SEFAA Bylaws states: Each director, principal officer, and member of a committee with governing board delegated powers shall annually sign a statement which affirms such person: 11.6.1 Has received a copy of the conflict of interest policy; 11.6.2 Has read and understands the policy; 11.6.3 Has agreed to comply with the policy; and 11.6.4 Understands the corporation is charitable and in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.

Appropriate data is described in 11.5.4.3.1 through 11.5.4.3.5. Article 11.5.4.4 states: The terms of compensation and the basis for approving them shall be recorded in written minutes of the meeting of the board or compensation committee that approved the compensation. The details for the required documentation are specified in 11.5.4.4.1 through 11.5.4.4.7.
