ORDINANCE NO. 11- 01

AN ORDINANCE RELATING TO FLY-DUMPING

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF GRANDVIEW, ILLINOIS:

SECTION 1: DEFINITIONS

As used in this Ordinance, the following words have the following meanings:

"Garbage" means wastes resulting from the handling, preparation, cooking and consumption of food and wastes from the handling, storage and sale of produce.

"Refuse" means combustible trash, including, but not limited to, paper, cartons, boxes, barrels, wood, excelsior, tree branches, yard trimmings, wood furniture, bedding; noncombustible trash, including, but not limited to, metals, tin cans, metal furniture, dirt, small quantities of rock and pieces of concrete, glass, crockery, other mineral waste, and street rubbish, including, but not limited to, street sweepings, dirt, leaves, catch-basin dirt, contents of litter receptacles, but refuse does not mean earth and wastes from building operations, nor shall it include solid wastes resulting from industrial processes and manufacturing operations such as food processing wastes, boilerhouse cinders, lumber, scraps and shavings.

"Ashes" means residue from fires used for cooking and for heating buildings.

"Construction and demolition debris" means any construction or demolition materials, scraps, or matter usually discarded during or after construction or demolition of buildings, roads and other structures.

"Litter" means any discarded, used or unconsumed substance or waste. "Litter" may include, but is not limited to, any garbage, trash, refuse, debris, rubbish, grass clippings or other lawn or garden waste, newspaper, magazines, glass, metal, plastic or paper containers or other packaging construction material, abandoned vehicles (as defined in the Illinois Vehicle Code),

motor vehicle parts, furniture, oil, carcass of a dead animal, any nauseous or offensive matter of any kind, any object likely to injure any person or create a traffic hazard, potentially infectious medical waste as defined in Section 3.360 of the Environmental Protection Act, or anything else of an unsightly or unsanitary nature, which has been discarded, abandoned or otherwise disposed of improperly.

“Fly-dumping” means dumping, depositing, dropping, throwing, discarding, leaving, or causing or permitting the dumping, depositing, dropping, throwing, discarding, or leaving, of garbage, refuse, ashes, construction and demolition debris, on any public lands or thoroughfare or at sites or locations which are not authorized to accept such wastes, debris or other materials, except by the owner or lessee of such site or location.

SECTION 2: FLY-DUMPING PROHIBITED

Fly-dumping is prohibited within the corporate limits of the Village of Grandview.

SECTION 3: PUBLIC NUISANCE DECLARED

Fly-dumping is hereby declared a public nuisance.

SECTION 4: PENALTIES Any person, firm or corporation who

engages in any act of fly-dumping shall be fined \$750.00 upon conviction for each offense, and shall in addition be liable to the Village for the actual cost of cleanup relating to each separate offense.

SECTION 5: NON-EXCLUSIVITY Prosecution for violation of this

ordinance shall not be the exclusive means by which the Village may address an offense of fly-dumping. The Village may in its discretion bring a proper action to abate or restrain a public nuisance, and may pursue all other remedies available under law.

SECTION 6: PUBLICATION, EFFECTIVE DATE AND REPEALER

This Ordinance is effective upon its passage, approval and publication as required by law. The Clerk shall forthwith publish this Ordinance in pamphlet form. Ordinance No. 270, adopted August 9, 1988, relating to Fly-Dumping, is hereby repealed. The provisions of this Ordinance are severable, and in the event any provision hereof is unenforceable, the remainder of the Ordinance shall be enforced.


