CONSTITUTION

1 THE CLUB SHALL BE KNOWN AS THE Le FEVRE PENINSULA SKID KIDS INC.
HEREAFTER KNOWN AS THE L.P.S.K.

2 **OTHER SECTIONS OF THE L.P.S.K.**

NO SECTION OF THE CLUB SHALL BE ALLOWED TO USE ANY NAME OTHER THAN THE Le FEVRE PENINSULA SKID KIDS WITH THE EXCEPTION TO THE RACING TEAMS WHO MAY BE TITLED Le FEVRE CYCLE SPEEDWAY.

3 **AIMS OF THE CLUB.**

1. TO PROVIDE A HEALTHY PASTIME FOR THE YOUNG
2. TO TEACH HOW TO LEAD OTHERS EFFECTIVELY
3. TO TEACH THE VALUE OF GOOD SPORTSMANSHIP
4. TO PROVIDE A CLEAN AND HEALTHY SPORT OF SPECIAL APPEAL TO THE YOUNG WHERE A COMMON INTEREST CAN BE SHARED
5. TO ENCOURAGE GOOD CITIZENSHIP AND OBSERVANCE OF ROAD SAFETY

4 **CLUB COLOURS**

THE CLUB COLOURS SHALL BE BLACK, WHITE AND RED

5 **THE EXECUTIVE**

THE PRESIDENT, SECRETARY, FINANCIAL MANAGER AND A MEMBER OF THE MANAGEMENT COMMITTEE SHALL FORM AN EXECUTIVE COMMITTEE. THREE MEMBERS OF THE EXECUTIVE SHALL CONSTITUTE A QUORUM. THE EXECUTIVE SHALL MAKE ALL FINAL DECISIONS IN THE MATTER OF POLICY, APPOINTMENTS AND BUSINESS ACTIVITIES OF THE CLUB.

THE EXECUTIVE SHALL :

1. RESOLVE ALL DISPUTES WITHIN THE CLUB.
2. HEAR ALL APPEALS
3. HAVE THE RIGHT TO VETO, SET ASIDE, OR REJECT ANY DECISIONS, APPOINTMENTS OF THE UNDERTAKINGS OF THE MANAGEMENT COMMITTEE.

6 THE MANAGEMENT COMMITTEE OF THE L.P.S.K.

6.1 HEREAFTER SHALL BE REFERRED TO AS "THE COMMITTEE" .

6.2 COMPOSITION

THE COMMITTEE SHALL CONSIST OF A PRESIDENT , SECRETARY, MANAGER, TREASURER, A REFEREE AND OTHER ELECTED MEMBERS WHICH WILL CONSTITUTE THE COMMITTEE OF THE L.P.S.K. ALL MEMBERS OF THE COMMITTEE SHALL BE FINANCIAL MEMBERS AT ALL TIMES, LIFE MEMBERS ARE DEEMED TO BE FINANCIAL.

6.3 DUTIES OF THE COMMITTEE

- a. TO FURTHER THE AIMS OF THE CLUB
- b. TO SUPERVISE THE FINANCES OF THE CLUB
- c. TO DETERMINE THE POLICIES OF THE CLUB
- d. TO SAFEGUARD THE TRACK AND ALL THE PROPERTIES OF THE L.P.S.K. SHALL BE OF GREATER IMPORTANCE OF ANY PARTICULAR RIDER

6.4 POWERS OF THE COMMITTEE

THE COMMITTEE SHALL HAVE THE POWER TO EFFECT IMPROVEMENTS IN MATTERS TOUCHING THE WELFARE OF THE CLUB SUCH AS POLICY, BEHAVIOR, DISCIPLINARY MATTERS AND GENERALLY ANY MATTERS OF THE CLUBS INTEREST.

6.5 AGE LIMIT

ALL MEMBERS OF THE COMMITTEE SHALL HAVE ATTAINED THE AGE OF EIGHTEEN YEARS.

6.6 MEETINGS

COMMITTEE MEETING WILL BE HELD MONTHLY OR AT THE DISCRETION OF THE EXECUTIVE. ANY FINANCIAL MEMBER OF THE CLUB IS ABLE TO ATTEND MEETINGS BUT ARE NOT ELIGIBLE TO VOTE.

6.7 ELECTION OF COMMITTEE

OFFICE BEARERS OF THE COMMITTEE SHALL BE ELECTED ANNUALLY BY THE OUTGOING COMMITTEE OF THE L.P.S.K. THE COMMITTEE RETAINS THE RIGHT TO CALL FOR THE RESIGNATION OF ANY OFFICER OR MEMBER SHOULD IT BE DESIRED

6.8 FAILURE TO ATTEND COMMITTEE MEETINGS

SHOULD ANY MEMBER OF THE COMMITTEE WISH TO BE ABSENT FROM ANY MEETING HE/SHE SHALL SEND TO THE SECRETARY OR PRESIDENT AN APOLOGY FOR SUCH ABSENCE. SHOULD A MEMBER ABSENT HIMSELF/HERSELF FROM THE COMMITTEE FOR THREE CONSECUTIVE MEETINGS HIS/HER SEAT SHALL BE DECLARED VACANT AND THE PRESIDENT SHALL CALL FOR NOMINATIONS TO BE RECEIVED AND IF NEED BE A BALLOT BE TAKEN TO FILL SUCH VACANCY.

6.9 QUORUM

FIVE FINANCIAL COMMITTEE MEMBERS SHALL CONSTITUTE A QUORUM FOR A MEETING.

7. MEMBERSHIP TO THE L.P.S.K.

MEMBERSHIP TO THE L.P.S.K. SHALL BE SUBSCRIBED ANNUALLY AT A FEE DETERMINED BY THE COMMITTEE OF TH L.P.S.K.

8. RELIGIOUS AND POLITICAL AFFILIATIONS

THE L.P.S.K. SHALL HAVE NO RELIGIOUS OR POLITICAL AFFILIATIONS.

9. BUSINESS CONTRACTS

ALL BUSINESS CONTRACTS PUBLICITY , SPONSORSHIP, ETC. SHALL BE HANDLED BY THE COMMITTEE OR EXECUTIVE

10. OBSERVANCE OF RULES AND CONSTITUTION

ALL BUSINESS CONTRACTS ,SPONSORSHIP OR PUBLICITY WILL BE HANDLED BY THE COMMITTEE AND EXECUTIVE. NO MEMBER SHALL USE THE CLUB NAME UNLESS SANCTIONED BY THE COMMITTEE

11. ALTERATION TO CONSTITUTION

NO ALTERATION TO THESE RULE SHALL TAKE PLACE UNLESS FOURTEEN CLEAR DAYS NOTICE SHALL BE GIVEN TO THE COMMITTEE AND A MEETING OF FINANCIAL MEMBERS . ALL PROPOSED ALTERATIONS OF THE RULES SHALL BE DEALT WITH BY A MEETING HELD FOURTEEN DAYS LATER OF SUCH MEMBERS, A MAJORITY OF THE FINANCIAL MEMBERS MUST BE IN FAVOUR BEFORE SUCH ALTERATIONS TAKE PLACE. ALL ALTERATIONS SHALL BE SUBJECT TO FINAL APPROVAL BY THE EXECUTIVE.

12. AMATEUR STATUS OF RIDERS

ALL RIDERS OF COMPETITIONS IN THE L.P.S.K. MUST BE AMATEURS

13. TEAMS

THE NUMBER OF TEAMS SHALL BE DETERMINED BY THE EXECUTIVE

14. **MANAGER**

THE DUTIES OF MANAGER INCLUDE ANNOUNCER HANDICAPPER AND PROGRAMME MANAGER. THE MANAGER SHALL AT ALL TIMES HEED THE ADVICE OF THE COMMITTEE ON ANY THESE MATTERS THAT SHALL BE BROUGHT BEFORE THE COMMITTEE

15. **TEAM CAPTAINS**

THE CAPTAIN OF TEAMS SHALL BE ELECTED BY THE COMMITTEE
THE CAPTAIN SHALL

- a. SUPERVISE THE MANAGEMENT OF HIS/HER TEAM.
- b. SET A GOOD EXAMPLE FOR ALL MEMBERS TO FOLLOW.
- c. PERFORM ANY DUTY AS AUTHORIZED BY THE COMMITTEE.
- d. SHOULD ATTEND ALL CLUB FUNCTIONS
- e. ANY CAPTAIN WHO, IN THE OPINION OF THE COMMITTEE FAILS TO CARY OUT THESE DUTIES , MAY AT THE DISCRETION OF THE COMMITTEE BE ASKED TO RESIGN HIS CAPTAINCY.

16. **NEW MEMBERS**

NEW MEMBERS SHALL BE ALLOCATED TO A TEAM AT THE DISCRETION OF THE MANAGER WHO SHALL ENDEAVOR TO MAINTAIN AN EVEN BALANCE OF TEAM PERFORMANCES

17. **UNIFORMS**

ALL RIDERS SHALL WEAR A CRASH HELMET. THE REFEREE SHALL .AS MUCH AS IN HIS/HER POWER ENSURE THAT RIDERS HELMETS ARE FITTED CORRECTLY , BUT ULTIMATELY IT IS THE RESPONSIBILITY OF THE RIDER (OR HIS PARENTS) TO ENSURE THAT HIS/HER HELMET IS FITTED CORRECTLY.

EACH TEAM HAS IT'S OWN RACING TOP, NO RIDER IS PERMITTED TO PARTICIPATE IN ANY EVENT WITHOUT HIS/HER PROPER RACING TOP, NEW RIDERS ARE EXPECTED TO OBTAIN HIS/HER RACING TOP AS SOON AS POSSIBLE

18. **RACE FEES**

ALL MEMBERS OF THE L.P.S.K. MUST BE REGISTERED BEFORE THEY RACE. RACE FEES ARE SET BY THE COMMITTEE AND CAN BE SUBJECT TO CHANGE AS THE COMMITTEE SEE FIT.

19. **TRACK OFFICIALS AND THEIR DUTIES**

- a. STARTER / SCORER, SHALL START RACES AND RECORD THE RACE RESULTS
- b. TRACK MANAGER, SHALL HAVE SOLE RESPONSIBILITY OF TRACK AREA
- c. PIT STEWARD , TO BE IN CONTROL OF PIT AREA AND ENSURE THAT ALL RIDERS ARE ON THE TRACK PROMPTLY FOR THEIR RACES, HE/SHE SHALL BE RESPONSIBLE FOR THE DRAWING OF GRID POSITION FOR RACES, ALSO SHALL KEEP UNAUTHORIZED PERSON FROM PIT AREA

19 CONTINUED

d. REFEREE – AUTHORITY AND STATUS

1. ALL RACING SHALL BE UNDER THE SOLE CHARGE OF THE REFEREE WHOSE DUTY IS TO ENSURE THAT NO ONE INDULGES IN UNFAIR, DANGEROUS ,UNSCRUPULOUS OR ILLEGAL RACE TACTICS, THE REFEREE SHALL ENFORCE THE RULES AND ANY DECISION MADE IN CONNECTION WITH RACE MEETING SHALL BE FINAL .ALL PROTESTS REGARDING THE RULINGS OF THE REFEREE IN-SO-FAR AS THE RESULT OF RACE, MATCH OR MEETING IS CONCERNED SHALL BE DEEMED OUT OF ORDER AND UNACCEPTABLE
2. PENALTIES IMPOSED BY THE REFEREE SHALL NOT EXCEED ONE MONTHS SUSPENSION.
3. SHOULD THE REFEREE IN HIS/HER WISDOM CONSIDER AN OFFENCE WARRANTS A GREATER PENALTY HE SHALL APPLY THE ONE MONTHS PENALTY AND RECOMMEND TO THE EXECUTIVE THAT A FURTHER PENALTY BE IMPOSED
4. THE EXECUTIVE SHALL ACCEPT AND OBSERVE ALL PENALTIES IMPOSED BY THE REFEREES AND DELIBERATION WILL NOT BE CARRIED OUT UNLESS AN APPEAL HAS BEEN LODGED
5. THE REFEREE SHALL ENFORCE THE RULES O RACING FROM THE GRAND PARADE UNTIL THE COMPLETION OF THE RIDERS MEETING

20. **APPEALS**

- a. CLUB MEMBERS- ANY CLUB MEMBER SUSPENDED FOR MORE THAN ONE DAY WHO FEELS HE/SHE HAS BEEN HARSHLY TREATED MAY APPEAL TO THE EXECUTIVE TO HAVE THE PENALTY SET ASIDE OR REDUCED.
- B COMMITTEE MEMBERS- ANY MEMBER OF THE COMMITTEE ,IF IN POSSESSION OF ADDITIONAL EVIDENCE OR FEELS THE PENALTY IMPOSED IS TO LENIENT, OR TO HARSH, APPEAL TO THE EXECUTIVE TO HAVE THE PENALTY INCREASED, OR DECREASED.
- C APPEALS ARE TO BE LODGED WITH SECRETARY OR MANAGER. WHO WILL IN TURN NOTIFY THE EXECUTIVE THAT AN APPEAL HAS BEEN LODGED
- D THE EXECUTIVE SHALL CONVENE WITHIN 72 HOURS OF SUCH AN APPEAL BEING LODGED AFTER THE HEARING THE EXECUTIVE MAY

1/.CONFIRM THE PENALTY	2/.SET ASIDE THE PENALTY
3/.REDUCE THE PENALTY	4/. INCREASE THE PENALTY
- E NON RACING OFFENCES REPORTED TO THE REFEREE WHERE HE/SHE IS LOATHED TO IMPOSE A SUSPENSION SHALL BE REFERRED TO THE EXECUTIVE FOR ACTION

21 **PERSONAL PROPERTY**

THE L.P.S.K. WILL NOT BE HELD RESPONSIBLE FOR ANY PROPERTY WHATSOEVER LOST, DESTROYED, DAMAGED, LEFT OR STOLEN ON OR FROM THE AREA CONTROLLED BY THE L.P.S.K.

22. **PROCEDURE AT A NORMAL RACE MEETING**

- A/. THE RACE MEETING SHALL COMMENCE AT A TIME STIPULATED BY THE COMMITTEE AND THE FIRST EVENT SHALL BE THE GRAND PARADE WITH PLAYING OF THE CLUBS FAN FARE
- B/. WHENEVER POSSIBLE THE RACE MEETINGS WILL BE AMPLIFIED
- C/. THE PITS WILL BE KEPT CLEAR OF UNAUTHORIZED PERSONS
- D/. ALL RIDERS NOT ACTUALLY RACING MUST KEEP OFF THE TRACK , OUT OF THE CENTRE AND CLEAR OF THE PIT GATES LEADING TO THE TRACK.

23 **INJURIES**

THE Le FEVRE PENINSULA SKID KIDS INC. WILL NOT BE LIABLE FOR ANY INJURIES RECEIVED BY ANY PERSON DURING ANY EVENT. THE Le FEVRE PENINSULA SKID KIDS INC. WILL NOT PAY FOR ANY MEDICAL OR HOSPITAL ACCOUNTS RECEIVED BY MEMBERS .

24 **BEHAVIOR OF MEMBERS**

- 1/. NO MEMBER WILL BEHAVE IN A MANNER WHICH IS LIKELY TO GIVE THE CLUB A BAD NAME
- 2/. THERE WILL NO SWEARING IN THE CLUB AND CLUB AREA.
- 3/. ALL MEMBERS WHO ATTEND CONTESTS OR EVENTS WHERE THE NAME OF THE L.P.S.K. IS OFFICIALLY REPRESENTED OR WHERE THE NAME OF THE L.P.S.K. BEING USED IN CONJUNCTION THEREWITH OR ATTENDS ANY FUNCTION ARRANGED BY OR HELD AT THE PREMISES OF THE L.P.S.K. SHALL BE RESPONSIBLE TO THE EXECUTIVE COMMITTEE FOR THEIR CONDUCT. THIS SHALL APPLY TO TIMES OF ARRIVAL OR DEPARTURE

25 **CLUB REPUTATION**

ANY MEMBER FOUND TO HAVE JEOPARDISED OR DAMAGED THE REPUTATION THE L.P.S.K., BY ACTION OR STATEMENTS OF BEHAVIOUR CONTARY TO THESE RULES SHALL BE BROUGHT BEFORE THE EXECUTIVE AND DISCIPLINED ACCORDINGLY.

26 **LIFE MEMBERSHIP**

- 1/. ALL RIDERS AND MEMBERS MUST BE FINANCIAL FOR THE FULL PERIOD TO RECEIVE LIFE MEMBERSHIP.
- 2/. RIDERS AND FINICAL /ACTIVE MEMBERS SHALL BE ELIGIBLE FOR LIFE MEMBERSHIP AFTER A PERIOD OF SEVEN YEARS , FINANCIAL BUT NON ACTIVE MEMBERS SHALL BE ELIGIBLE AFTER NINE YEARS
- 3/. ACTIVE / NON ACTIVE – ACTIVE SHALL MEAN THAT THE MEMBER HAS HAD AN ACTIVE INPUT TO THE CLUB i.e. TRACK OFFICIALS OR COMMITTEE MEMBERS NON ACTIVE HAVING DONE NONE OR VERY LITTLE TO DO WITH THE RUNNING OF THE CLUB

4/. TO QUALIFY FOR LIFE MEMBERSHIP A RIDER / MEMBER MUST COMPLY WITH THE ABOVE CONDITION CONSISTENTLY WITH OUT A BREAK OF MORE THAN SIX MONTHS

5/. SHOULD ANY DISPUTE ARISE OVER LIFE MEMBERSHIP THEN EACH CASE WILL BE JUDGED ON IT'S OWN MERITS.

6/. SHOULD A MEMBER DOUBLE THE AMOUNT OF TIME REQUIRED FOR HIS / HER LIFE MEMBERSHIP THEY WILL BE RECOGNIZED ON THE HONOUR BOARD WITH GOLD LIFE MEMBERSHIP.

7/. THE EXECUTIVE SHALL HAVE THE FINAL SAY ON LIFE MEMBERSHIP AND THAT DECISION SHALL BE FINAL AND BINDING

27

NON PROFIT CLAUSE

THE ASSETS AND INCOME OF THE ORGANIZATION SHALL BE APPLIED SOLELY IN FURTHERANCE OF IT'S ABOVE MENTIONED OBJECTS AND NO PORTION SHALL BE DISTRIBUTED DIRECTLY OR INDIRECTLY TO THE MEMBERS OF THE ORGANIZATION EXCEPT AS A BONA FIDE COMPENSATION FOR THE SERVICES RENDERED OR EXPENSES INCURRED ON BEHALF OF THE ORGANIZATION.

DISSOLUTION CLAUSE

IN THE EVENT OF THE ORGANIZATION BEING DISSOLVED ,THE AMOUNT THAT REMAINS AFTER SUCH A DISSOLUTION AND THE SATISFACTION OF ALL DEBTS AND LIABILITIES SHALL BE TRANSFERRED TO ANOTHER ORGANIZATION WITH SIMILAR PURPOSES WHICH IS NOT CARRIED FOR THE PROFIT OR GAIN OF ITS INDIVIDUAL MEMBERS.
